

CSC 2017-2018 Member Commitment Agreement



We agree to the terms of this Member Commitment Agreement including each of the following conditions:

All members are committed to Commonwealth Soccer Club (CSC), including financially committed, taking on the burden of the full fees set forth regardless of any decision to leave the club for any reason. For members registered to the Academy through U14 age groups, this commitment includes both the Fall 2017, and Spring 2018. For members registered to the U15 through U19 players, this commitment includes the Spring 2017 season, which begins in November 2017. A minimum first payment of 20% of the specified club fees is due within 24 hours of being contacted following tryouts to secure a position with the club. In addition, for all players U10-U19, a \$200.00 assessment down payment is due at registration. All payments must be made via credit card or electronic check through the Affinity registration process, unless an alternate form of payment is pre-arranged with the CSC treasurer. Financial Assistance may be available upon request.

PAYMENT PROCESSING

Payments made through the Affinity payment system will be auto debited from your credit or debit card, or via electronic check, per the payment plan chosen. Should there be any reason whereby the system cannot process payment, you are still fully accountable for payment on the due date of your payment plan via check or money order payable to Commonwealth Soccer Club at the following address: P.O. Box 23253, Lexington, KY 40253-3253.

NON-PAYMENT

If you have not made timely payment per the appropriate payment plan, CSC will suspend player activities after a 10-day notification. The player will be suspended until the Financial Committee reinstates the player. A \$25 reinstatement fee will be required upon payment of the past due balance. CSC further reserves the right to dismiss players whereby habitual late payment becomes an issue.

TEAM ASSESSMENTS

Team Assessments for tournaments, referees, coaches travel expenses, and the like must be paid in full PRIOR to participation in any official games or tournaments. Inability to pay team assessment per the due dates set by the team manager will result in suspension from league and tournament play.

REFUNDS

All fees and assessments are NON-REFUNDABLE. Players who experience a season ending injury or illness may request a partial refund in writing to the CSC Board of Directors if fewer than four games have been played in a season, in which case the Board will make a determination on whether to refund all or a portion of the fees. All requests must be accompanied by a written statement from an attending physician certifying the season ending injury. After four games, no refunds will be granted.

PLAYER TRANSFER AND RELEASE

CSC players on rosters in 2017-2018 are bound to that team for the entire playing year unless he/she requests a transfer. Requests must be made in writing by completing a TRANSFER request found in the KYSA Affinity system under the player's account. The CSC Board of Directors will review these requests and their decision will be final. A player will not be granted a release or transfer until all 2017-2018 CSC registration fees and all CSC team assessments have been paid. In addition, CSC will charge a \$200.00 administrative transfer fee, which is separate from any fees imposed by KYSA.

CERTIFICATIONS

I understand that all players play at their own risk, and I assume all legal responsibilities for any and all injuries incurred by my child while playing and/or practicing for CSC. I further fully release and discharge CSC, its agents, employees, and directors of and from any and all actions, damages and compensation of every type, kind and character whatsoever which may be sustained, either directly or indirectly, arising out of my child's participation, and represent & warrant that I am of full legal capacity to execute this Agreement.

I agree to abide by all club policies, financial requirements and represent the club with the highest standards of conduct, character and integrity. I understand that failure to abide by the terms set forth in any CSC policy may result in my child's removal from the club and forfeiture of any payments made, or in other disciplinary action.
